When payment is due

HIP appointments (both)	Included — nothing to pay at these appointments.
Assessment — \$800	ADHD formal assessment due before that appointment.
Optional, if you choose to start medication, 6 months Monitoring, Treatment Plan & Dosage Review — \$400	Due at or before your 2-week GP follow-up appointment.
Complete pathway — \$1,200	Spread across your appointments as above.
Psychiatrist review — \$170	Only if recommended. Always discussed with you first.
Face-to-face in addition to the two included	Standard consultation fee applies.
After 6 months	Standard consultation fee applies for ongoing monitoring.

The fee does not depend on the diagnosis

Please read this carefully.

Whether or not ADHD is diagnosed, the assessment fee (\$800) is the same.

You are paying for the assessment — the time and expertise of the clinicians. A thorough assessment that finds no ADHD is still valuable: it rules something out

and points to what is actually going on.

The bundle (\$400) applies only if treatment is initiated.

If you are not comfortable with this, please speak with us before you begin.

Cancellations

Please give us at least 24 hours' notice to cancel or reschedule. Late cancellations or non-attendance will incur a \$50 fee.
